BE IT REMEMBERED, That a Special Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 14th day of July, 2016 at 9:00 o'clock A. M. with Judge Mike Sutherland, Commissioners Dwayne Beran, Keith Schroeder, David Hildebrand and John B. Landolt, Jr. present and County Clerk-Anna L. Schielack in Attendance when the following business came before Court:

Judge Sutherland called the meeting to order.

The Court had a discussion with the following from FEMA & TDEM:

It was discussed that the threshold for Burleson County was \$61,358 for the damage assessments due to the floods in May 2016.

Motion made by Commissioner Schroeder and seconded by Commissioner Hildebrand to Recess Court at 9:15 a.m. for roads, bridges, etc... to be assessed.

Motion made by Commissioner Landolt and seconded by Commissioner Beran to Reconvene Court at 3:35 p.m. FEMA and TDEM representatives stated that Burleson County exceeded the threshold amount and that the next step would be for public entities to ask for public assistance. Each applicant will meet individually with FEMA. FEMA will write project for Preliminary Damages and then submit project. FEMA then reviews and sends to the County Judge for him to sign off on the project. After Commissioners' Court approval and the signature of the County Judge the project goes to the State for final approval and pay out. The commissioners were reminded to obtain TCEQ permits for debris removal. The following amounts are preliminary figures for the following damages:

Precinct 1	\$ 65,000
Precinct 2	\$ 150,000
Precinct 4	\$ 165,800
City of Somerville	\$ 212,000
Extra for the County	\$ 20,000
Utilities	\$ 10,000

Motion made by Commissioner Landolt and seconded by Commissioner Schroeder to Adjourn the Meeting.
