M. with Judge Keith Schroeder, Commissioners Joe F. Baldwin, Jr., Vincent Svec, David Hildebrand and Carol Hill present and County Clerk-Anna L. Schielack were in attendance when the following business came before Court:

- Department Reports- Sheriff Gene Hermes reported over the phone that the Department has 46 inmates in Jail with 3 from Milam County and 2 are ready to be transported to TDC. They have 3 confirmed COVID-19 Cases at the Sheriff Department, plus 1 in Jail and sending 4 additional for testing. County Attorney Susan Deski reported they are holding off on Jury trials in December 2020 for both County & District Courts. DPS Sgt. Stohler reported they have 7 troopers at this time with 1 vacancy. Those that were quarantined are back at work, and they are still doing rotations in Austin, TX.

The Judge also reported that the bid for Steel roller for Precinct 4 of \$109,500.00 will be on the next agenda to be approved.

- a. Monthly Sales Tax- \$101,129.00 (up from the last two months but 25% less than last year at this time)
 - b. Quarterly Hotel Tax- \$7,089.88 last quarter
- 17) On Commissioner's Report-Commissioner Baldwin from Precinct 1 is working on Gun Range Road and Commissioner Svec from Precinct 2 is doing culvert work.
