Shawn Edwards our Mental Health Officer gave his Quarter 1 '23-'24 Crisis Intervention Report starting from October 1, 2023 through December 31, 2023 reporting there have been 93 mental health/crisis calls for service in Burleson County. (See attachment) He also reported he had 9 anger management grads since 1/1/23, 8 took classes from License Chemical Dependency Council with 3 on tract to graduate from LCDC next month. There will be a Mental Health Workshop on June 26th from 10 a.m.-4 p.m. with location to be determined. Jessica Lucero-Tax Collector reported they are up to date on tax payments. D. J. Oliver- Elections Administrator reported that we had 183 vote on the first day of early voting. Also, she reported that word was going around that the voting system was not certified, but she presented the Court a letter from the U.S. Election Assistance Commission that the SLI Compliance is an EAC accredited Voting System Test Laboratory (VSTL), and that they are certified.
